ORDER

As per the Government Order, read as 1st paper above, Administrative Sanction was issued for the negotiated purchase of 13.2698 hectares (32.1 acres) of land for developing as Green Industrial Park with the objective to construct Regional Recycling Facilities at Panappuzha village of Payyannur Taluk in Kannur district.

(2) As per the letter, read as 2nd paper above, one of the owners pointed out that few survey numbers and areas including that of road access to be purchased are not included in the Administrative Sanction order.

(3) The District Collector, Kannur, as per the letter read as 4th paper above, clarified that the valuation has been completed and is applicable for the total area identified and surveyed which includes the survey numbers which are pointed out as missing. The District Collector, Kannur has also informed that the valuation of the improvements for the land under survey No. 55/566, identified for widening the access road will be undertaken after getting revised Administrative Sanction, after including the said survey number which was not included in the earlier order.

(4) Project Director, Kerala Solid Waste Management Project, as per the letter read as 6th paper above, has requested to issue revised Administrative Sanction for the negotiated purchase of 14.866 hectares (36.735 acres) of land at Panappuzha village and to entrust District Collector, Kannur to complete the process and procedures for the negotiated purchase. Accordingly Government issued revised Administrative Sanction, as per the GO read as 7th paper above. But in the GO the extent of the land was erroneously marked as
