### **Instruction to Applicants**

### 1. Eligibility

- 1.1. The Vendor shall be an ICT company, preferably in the business of software and web application service for at least two (2) years holding Microsoft authorized Partner Certificate.
- 1.2 Any vendor submitting the quotation shall have supplied MS Project subscription (minimum of 25 licenses of any category) to a minimum of one organization in the last 1 (one) year.

#### 2. Scope of service:

The successful Applicant shall supply, install and offer training of MS Project. The licenses/subscription required are:

#### 3. Delivery period

The Service Provider shall complete the supply of licenses and installation within a timeframe of 5 (Five) Working Days ("**Delivery Period**") from the date of issue of Supply Order. The Service Provider is expected to follow the following time schedule:

#### 4. Continuous Service:

The vendor shall provide continuous support throughout the contract period to ensure that MS Project licenses and software are functional to the full extend. This shall include provision of all necessary updates included within the packages purchased, failing which the contract shall be terminated without any notice. For avoidance of doubt, in case of a failure from the Supplier to provide necessary support as required herein, within 48 hours of intimation, the contract shall be liable for termination forthwith.

#### 5. Submission of Quotation:

The Quotation shall be submitted in a sealed cover with superscription "Quotation for the supply, installation and training of MS Project". The details of the supplier and the quotation shall be submitted in the format enclosed

with this notice.

#### **6 Quotation Prices**

- a. The contract shall be for the full value of MS Project software supply and deployment support as required herein. Corrections, if any, can be carried out by editing the information before electronic submission.
- b. All duties, taxes and other levies payable on the software, services etc. shall be included in the total price.
- c. GST and any other taxes, which will be payable on the Non-Consulting services at the prevailing rates shall be shown separately as required in the format for the submission.
- d. The rates quoted by the applicant shall be fixed for the duration of the contract and shall not be subject to enhancement
- e. The Prices shall be quoted in Indian Rupees only.

#### 7 Clarification of quotations:

During opening or evaluation, the purchaser may at its discretion, seek the required clarification from the applicants. However, no change in prices or substance of the quotation shall be sought, offered or permitted. If the quotation is not substantially responsive, it will be rejected by the Purchaser and may not subsequently be made responsive by the applicant by correction of the non-conformity. Unsigned communication/ quotations will not be accepted and will be rejected summarily.

#### **8 Evaluation of Quotations**

- a. The evaluation shall be based on the total quote for Supply Installation & training and required continuous support for MS Project Software including GST and any other taxes, which will be payable for these non-consulting services.
- b. Evaluation of the quotation shall be made strictly in terms of provisions and criteria disclosed in the quotation document for the quantities mentioned in the quotation. However, KSWMP reserves the right to purchase the total quantities or in part thereof.
- c. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotation, cancel the quotation process and reject all quotations at any time prior to the award of the contract. Also, KSWMP reserves the right to cancel the purchase order if the firm fails to comply with the delivery schedules without any notice.
- d. Please note that KSWMP reserves the right to accept or reject any quotation and to annul the quotation process and reject all quotations at any time prior

to the award of contract, without thereby incurring any liability to the affected applicant or applicants.

#### 9. Award of contract:

- a. The Client will award the contract to the applicant whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- b. Notwithstanding the above, the Client reserves the right to accept or reject any quotations and to cancel the quotation process and reject all quotations at any time prior to the award of contract.
- c. The applicant whose quotation is accepted will be notified of the award of contract by the Client prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order (sample form attached).

#### 10. Payment:

Payment will be made on monthly basis through RTGS/NEFT upon submission of invoices receipt of ordered item and its satisfactory performance.

#### 11. Termination:

The contract shall be terminated prior to six months with a notice of 15 days. In the event of such termination, the dues shall be admissible only for such period of actual supply/service of the Supplier. All admissible bills shall be cleared within 30 days from the closing date of the contract.
