The Breakup of the Contract Price is: INR 1,73,94,200/- exclusive of local indirect taxes for Cluster 1 and Cluster 4 together.

- In addition to this contract amount, there is an allocation of INR 35,63,600/- towards the cost of tests, investigations and Task 3, which shall be paid on ad measurement basis against monthly invoices /- exclusive of local indirect taxes for Cluster 1 and Cluster 4 together. Employer's representative shall record the quantity consumption in a measurement book, which will be the basis for payment against variable amount.
- Any indirect local taxes chargeable in respect of this Contract for the Services provided by the Consultant shall be paid by the Consultant. The Client shall only reimburse Goods & Services Tax (GST) payable on the contract value by the consultants, as per Applicable Law in India subject to the Client, performing such duties in regard to the deduction of taxes as may be lawfully imposed. However, Consultant shall have to produce to the Client, all relevant documents establishing the proof of payment/ filing of return to the tax authority etc. The consultant shall register itself for GST with appropriate authority in India & shall provide the Registration Number to the Client.

- The amount of such taxes is INR 31,30,956/- for the Contract Price of INR 1,73,94,200/- and INR 6,41,448/- for the indicative sum of INR 35,63,600/- for tests, investigations and Task 3 for both Clusters 1 & 4.
